1) Purchase of a house in Madrid

Instructions on how to give for this purpose are included in the letter. Please pray for the advancement of the Lord's move on the Iberian Peninsula through the purchase of this property.

3) Follow-up of Bible distribution at the 2024 Summer Olympic Games in Paris

The Bible distribution during the 2024 Summer Olympic Games in Paris concluded on 9 September. SUBJECT: THE HOUSE NEXT TO THE MEETING HALL OF THE CHURCH IN MADRID

Dear saints and churches in the Lord's recovery:

In September 2018 a meeting hall was purchased for the church in Madrid. It is located in a triangular city block indicated by A in the map below.

In March 2021, house B next door to the meeting hall was purchased.

The church in Madrid was much blessed by the Lord since these two properties were purchased which enabled the church to experience a quantum advance. They caused the church to increase and the care for the saints of all ages prospered, especially for the young people. With these properties we were able to better take care of visiting saints, they allowed for the gatherings of all the responsible brothers of the Peninsula, and served as one of the European hubs for the FTTA gospel trips to several countries. After these two properties were acquired, we started dreaming about acquiring the remaining house on the block indicated by C on the map.

April 2024.

On August 17, 2024, the owner of house C notified us that she is selling the house and wanted to give us the first right of refusal.

***Ministerio Nuevo Hombre is our entity registered in the Special Section of the Registry of Religious Entities of the Ministry of Justice of Spain.**

It is a two-story house and was completely renovated in 2010. It sits on a plot of 400 m². It has an interior distribution of two completely independent apartments with a total living area of about 300 m²:

- The ground floor has: kitchen, living room, 3 bedrooms, a bathroom, air conditioning in one bedroom and the living room, garage and wrapping patio.
- The second floor has: large kitchen-dining room, living room, 3 bedrooms, 2 bathrooms (one included in the master bedroom), air conditioning in all rooms (including the kitchen), and large terrace with access from the kitchen and 2 of the bedrooms.
- The house has underfloor heating, independent on each floor, with a new common gas water heater and a large water tank which were recently installed.
- It has a good-sized patio, and terrace that surround the house with a large area above the garage.
- The asking price is 1,360,000 euros.

The house is in very good move-in condition. Based on comparables in the neighborhood, the asking price is reasonable.

With this house the entire block will be owned by us. With the two houses, the possibility of having sisters and brothers houses will be a reality, and generate income to support the work in the Peninsula. The potential for more hospitality capacity is also increased. Ownership of the block will provide a good facility for the Lord's further advance in Madrid , Spain and the Iberian Peninsula, which is an unusual opportunity and a strategic one.

On September 6 we signed the contract as follows:

1. Down payment of €250,0000 as initial earnest money.
2. On November 6, 2024, a second installment of €250,000.
3. On January 6, 2025, a third installment of €250,000.
4. On March 6, 2025, the balance of €610,000 to close.




En septiembre de 2018 se compró el local de reunión para la iglesia en Madrid. Está ubicado en una manzana triangular indicada por la letra A en el mapa que aparece abajo.

En marzo de 2021, se compró la casa B de al lado del local de reunión.

La iglesia en Madrid fue muy bendecida por el Señor desde que se compraron estas dos propiedades, lo que permitió a la iglesia experimentar un avance cuántico. Estas adquisiciones causaron que la iglesia aumentara y prosperara en el cuidado de los santos de todas las edades, especialmente de los jóvenes. También pudimos atender mejor a los santos que nos visitaban, celebrar las reuniones trimestrales de todos los hermanos responsables en la Península, y servir como uno de los centros para los viajes de evangelio del ETCA a donde llegaban los diferentes equipos de entrenantes para, a continuación, partir desde Madrid a los diferentes países de Europa. Después de adquirir estas dos propiedades, comenzamos a soñar con adquirir la casa restante en la manzana, señalada por la letra C en el mapa.

El 17 de Agosto de 2024, la vecina, propietaria de la casa C, nos escribió que por deferencia a nuestra comunidad, nos informa que va a vender la casa por si es de nuestro interés.

*Ministerio Nuevo Hombre es nuestra entidad inscrita en la Sección Especial del Registro de Entidades Religiosas del Ministerio de Justicia de España.

Es una casa de dos plantas que fue completamente reformada en 2010. Está situada en una parcela de 400 m². Tiene una distribución interior de dos apartamentos completamente independientes con una superficie total habitable de 300 m²:

- La planta baja tiene: cocina, salón, 3 dormitorios, un cuarto de baño, aire acondicionado en un dormitorio y en el salón, garaje y patio.
- La primera planta tiene: una amplia cocina-comedor, salón, 3 dormitorios, 2 baños (uno incluido en el dormitorio principal), aire acondicionado en todas las habitaciones (incluida la cocina), y una amplia terraza con acceso desde la cocina y 2 de los dormitorios.
- La casa tiene calefacción por suelo radiante, independiente en cada planta, con una caldera de gas natural nueva y un depósito grande para agua caliente de reciente instalación.
- Tiene un patio de buen tamaño y una terraza que rodea la casa con una gran área encima del garaje.
- El precio de venta es de 1.360.000 euros.

La casa está en muy buenas condiciones para entrar a vivir sin necesidad de ninguna reforma. Al hacer una comparación con otras propiedades similares en el vecindario, el precio de venta es razonable.

Con esta casa, toda la manzana será de nuestra propiedad. La posibilidad de tener casas de hermanas y casas de hermanos será una realidad y se aumentará la capacidad para hospitalidad. Tener la manzana completa como nuestra proporcionará un buen centro para un mayor avance del Señor en Madrid, en España, y en la Península Ibérica, lo cual es una oportunidad única y estratégica.

1. Pago inicial de 250.000 € en concepto de arras.
2. El 6 de noviembre de 2024, una segunda cuota de 250.000 euros.
3. El 6 de enero de 2025, una tercera cuota de 250.000 euros.
4. El 6 de marzo de 2025 se firma la compraventa con el resto de 610.000 €.



